Burgh House Limited will host one A4 page per organisation.

The page:

- may comprise text and pictures;
- must be delivered as a single Microsoft Word™ document, for version 2003 (.doc) or 2007 (.docx);
- must not exceed 1Mb in total file size.

UPDATES

The offer is not intended to allow regular or frequent updates and we do not expect to receive updates more than twice per year.

Therefore please design your page to describe your organisation in general and avoid, for example, details of recent or forthcoming events that will soon be out-of-date.

CONDITIONS OF ACCEPTANCE
